NOTICE: PERMITS REQUIRED FOR DITCHING

Please remember that permits are required for any work done in County ditches and rights-of-way, and are FREE to obtain. It is the responsibility of the landowner to contact the County prior to any proposed work in the County's developed or undeveloped rights-of-way, including items like approach construction or modifications, new ditches or deepening of existing ditches, brushing, and any other work. Rights-of-way are used for a variety of purposes and may have high pressure gas lines and oil pipelines running across them.
