PRIVATELY OWNED EQUIPMENT LIST

Contractors wanting to provide heavy equipment and gravel hauling services for Saddle Hills County, must register with the County annually by completing and submitting a Privately Owned Equipment Registration Form. These forms are available online at saddlehills.ab.ca/privately-owned-equipment, by scanning the QR code, or at the County Admin Building. You can register at any time, however; our construction season usually begins on, or around, April 1, and we urge interested contractors to submit their applications by **March 15, 2026**.



SAFETY TIPS FOR PASSING PLOWS & GRADERS

Please be aware of slow moving graders and snowplows. Our graders and plows use highways to get around the County, to ensure all of our roads remain safe and clean.

- Treat graders and plows as slow-moving vehicles and only pass when it is safe to.
- Watch for signal lights while on the highway.
- When graders and plows are working, please stay further back and pass only when it is safe or when the operator signals for you to do so.
- Allow graders and plows extra room at intersections, as they may be backing up or turning around.
- Stay behind any dust or snow clouds, so that oncoming traffic and grader and plow operators can see your vehicle clearly.

CERVICAL CANCER SCREENING NOW AVAILABLE

The Saddle Hills County Health Clinic is now offering cervical cancer screening (Pap tests) as part of its preventive health services. Screening helps detect cell changes early, often before cancer develops or symptoms appear. Women and people with a cervix aged 25 to 69 may be eligible and are encouraged to speak with their health care provider about screening options. 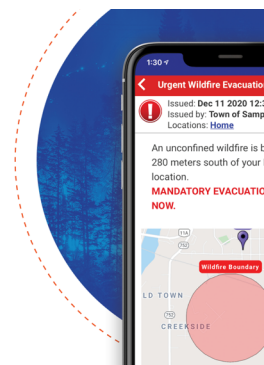
