WEED INSPECTORS BEGIN WORK

To help ensure the high quality of our crops and eliminate pests, our Weed Inspectors carry out regular annual inspections, looking for noxious and prohibited noxious weeds listed under the Weed Control Act and nuisance and pest species listed under the Agricultural Pests Act. So, if you see a County staff member in your field in the coming months, they are there to help! Weed Inspectors may park vehicles in field approaches but will never drive onto your land, and follow strict biosecurity protocols to prevent disease spread. RE-GRAVELLING & DUST CONTROL UNDERWAY

Please note that the County has begun re-gravelling and dust control on County roads. Please watch out for workers and large equipment, slow down, and drive with caution through these areas.

CAPTURE - REGISTER YOUR SECURITY CAMERA

Did you know you can register your security camera through CAPTURE (Community Assisted Policing Through Use of Recorded Evidence) to assist police in investigating crimes, such as property theft? ASSESSMENT RE-INSPECTIONS IN PROGRESS

Assessors, Aaron Steblyk and Brady Harder, will be out in Saddle Hills County during the week of **June 9-13, 2025**, conducting property re-inspections in the southern portion of the County, in the Gundy and Woking areas. Brady and Aaron will be driving a grey GMC Canyon and a white Chevrolet Silverado respectively, both sporting Saddle Hills County decals. Rotational re-inspections are carried out on a yearly basis, to verify and maintain the accuracy of the data on the Assessment Roll. Each year, approximately 25% of the municipality will be verified through this process. 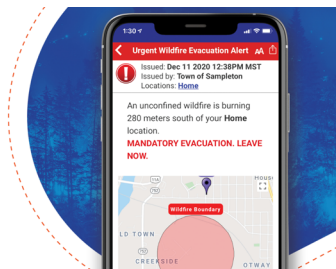
