## CHECK YOUR WINTER BURN PILES

With the fire season underway, everyone is encouraged to become familiar with FireSmart principles and to take an active role in wildfire prevention and mitigation by preparing their properties and communities accordingly. Please exercise extreme caution in forested areas and avoid burning under warm, dry and windy conditions. It is crucial that everyone remain up-to-date on fire bans and restrictions in their areas to reduce the risk of human-caused wildfires, which represented more than 60 per cent of wildfires this past season. For anyone who did any burning over winter, please check all sites, spreading out the remaining materials and soaking the area to ensure no more heat is being produced. Continue to check burn sites at regular intervals in the lead up to spring to confirm they have not reignited. ## 2024 FENCELINE SPRAYING AGREEMENTS - NOW AVAILABLE

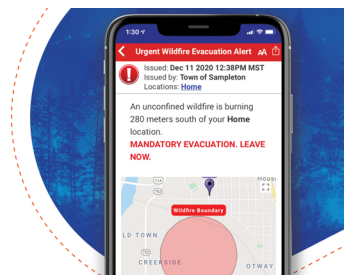
