#### **Use of Campsite Information**

- 1. The campground gates will open on Friday, May 10th. Your campsite must be vacant by Saturday, September 28th. Vehicle traffic is closed during the off-season.
- 2. Spring Lake Campground is currently an un-serviced campground.
- 3. Temporary accessory structures are permitted on seasonal sites only, subject to a \$500 deposit. This includes decks, storage sheds, fences. All accessory structures must be removed by end of season, or the \$500 deposit will be forfeited.
- 4. No dumping in unauthorized places within the campsite, campground or along the road. Sani-dump locations are available at the Hythe Municipal Campground or Beaverlodge Pioneer Campground.
- 5. A non-potable water filling location is available in the A-loop.
- 6. No parking on the campground roadway from May Long Weekend to September long weekend. No parking in vacant sites or other people's driveways without permission. If you have guests planning to visit, ask the campground caretakers where they should park.
- 7. Be respectful and considerate of other campers. Please be careful not to litter, damage property, or trespass on/through other people's campsites (including sites of absent tenants). Any activity or noise which may affect the comfort of other campers is not permitted. Your favourite music is often not your neighbour's; therefore, loud music and/or shouting is not allowed at any time.
- 8. Misusing, tampering, defacing, moving, or altering campground property or other camper's property is not tolerated. Inappropriate behavior will not be tolerated on or off your site. Anyone exhibiting violent behavior will face an immediate eviction and the involvement of law enforcement. You (leasee) are responsible for the behavior of your guests and site's occupants.
- 9. Construction, use of chainsaws or use of other loud equipment is prohibited.
- 10. Fireworks/firecrackers or Chinese/Sky lanterns are prohibited.
- 11. Quiet time is from 11:00 pm to 8:00 am. Audio equipment and noisy activities are prohibited during Quiet Time.
- 12. Policy violators or suspicious persons should be reported to management immediately. We ask that all complaints and concerns be directed to management. This allows us to address your concerns both expediently and efficiently. Your complaints will remain anonymous. Spring Lake Campground management reserves the right to have any person vacate the campground for 24 hours effective immediately upon violation of any of the campground's regulations. If uncooperative, a County Peace Officer will attend to enforce.
- 13. Please look after our forest. A permanent eviction will be given to anyone creating additional space, including paths, by destruction or removal of live trees or brush, without permission. Brush is damaged when stepped on/through repeatedly or used as storage space. Please notify us of dead trees around your site. If the tree is determined dead upon inspection, we will cut it down under our guidelines. In some cases, RVs are required to be moved off the site during the tree removal procedure. Planting additional vegetation (trees, flowers, plants) is also prohibited.
- 14. Your site must be tidy and free of open storage including behind, beside, and underneath structures. The bush is not part of your site and should never be used as such.
- 15. Spring Lake Campground Seasonal campsites are single family occupancy. Campsites may contain:
  - a. 1 recreational vehicle,
  - b. 1 sleeping tent,
  - c. 1 dining or screened tent,
  - d. 1 tow/passenger vehicle,
  - e. Approved accessory structure(s)
- 16. Additional units and tents are subject to additional fees. Permanent or overhead structures are not permitted. You must inform management in advance of anyone using your campsite in the event you and your leasee partner are both absent. You must submit the dates expected and name(s) of the individual(s) to the caretaker. The behavior of said guests will reflect on you, the leasee. All guests MUST register at the office upon arrival.
- 17. Garbage MUST be put in plastic bags, tied, and then deposited into either the bear proof bins within the campground loop or taken to the larger garbage bin located in the day use area parking lot.

Disposal of propane tanks, tires, mattresses, furniture, major appliances, and other large objects is your responsibility, and these items must be disposed of offsite. Fires are only allowed in firepits. To dispose of ashes, transfer (once cooled) into plastic bags, then place beside (not inside) garbage barrels. Please do not dump ashes into the bushes.

- 18. Golf carts are permitted. Speed limit is 10km/hour, and operators must be at least 14 years of age.
- 19. It is the responsibility of the seasonal camper should they wish to insure their property against loss, theft, or damage due to fire, or other acts of God.
- 20. Seasonal sites are neither transferable nor refundable.
- 21. Seasonal sites that become available part way through the season, will be assigned as per a standing waiting list, or through a draw process.
